Executive Director Row Receives Lifetime Achievement Award

Dr. Thomas Cornwell presented retiring Executive Director Constance Row the Academy's Lifetime Achievement Award. This award had been presented only two other times in the history

of the AAHCM. Ms. Row was thanked for her role in the Academy's accomplishments during her 18 years of service. For example, Dr. Cornwell mentioned that during her tenure the Academy had gone from nearly running out of cash (\$50,000 in bank) to current total assets of over \$900,000. Ms. Row thanked the Academy leadership and staff with whom she had worked over the years and applauded all of the inspiring members it had been her privilege to serve, who were "being the change they wanted to see."

Clinical Sessions Well Received

Ms. Lara Offenberger, PA-C presented on Pain Management- Hydrocodone. She emphasized the value of a pain management (contract) model with patients in place, and also of teaming up with a pain management specialist for expertise. Familiarity of state guidelines and regulations was critical as well as mastering the logistics drug transport,

IAH Day

The Academy conducted its 4th Annual IAH Day on May 13th. The meeting was attended by the 15 Academy practices participating in the Demonstration. Also in attendance this year were the CMS IAH management team consisting of CMS Innovation Center, Mathematica Policy Research (MPR), and Research Triangle Institute (RTI) staff, which together are managing and evaluating the Demonstration.

The IAH Day included a celebration of the three years of work by the practices, lessons learned, recommendations for regulatory and specification modifications in an extended or expanded Demonstration, and review of the opportunities IAH participation has provided for practices in the private market.

IAH Faculty member and Past President Dr. Peter Boling presented Linda Magno and Linda Colantino of the CMS Innovation Center with framed copies of the IAH legislation as a token of the Academy Learning Collaborative's appreciation in working with the Academy and the IAH practices through the initial three years of the Demonstration. The "Lindas" were appreciative of the comments and gift. This set the tone for a productive day.

communication, and clinical quality assurance.

Althea Lloyd, PhD identified the benefits of non-pharmacological approaches for managing Neuropsychiatric Symptoms (NPS) of dementia and summarized the DICE (Describe-Investigate-Create-Evaluate) approach for assessing and managing NPS. NPS affects 90% of dementia patents. Both a lack of treatment of NPS and also the mistreatment through automatic use of psychotropic medication produce negative impacts on patients. A patient case example was used to apply the DICE approach. The benefits of applying the structured DICE approach to the home-limited to enhance clinical practice to assess and manage challenging behaviors in dementia care were described.

Dr. Jon Salisbury presented on Managing Heart Failure at Home. He presented a diagnostic algorithm, which was followed by explicit pharmacological approaches and also non-pharmacological approaches to management. He concluded with educational guidance that practices can use with patients and caregivers to avoid hospitalization. He had not sent a heart failure patient to the hospital in 5 years.

Expert Sessions and Networking

The record number of attendees participated in numerous expert breakfast and lunch discussions covering a range of organizational practice management, specialty organizational, and technology topics. Attendance and evaluations that were received reflects the strong interest in practice management and operational details.

Dr. Richard Schamp Provides Overview of Importance and Methods of Accurate Diagnostic Coding

Dr. Richard Schamp of Capstone Performance Systems provided a well-regarded teaching presentation of diagnostic coding and also the relationship of diagnostic coding to Hierarchical Classification Categories (HCC). Dr. Schamp's presentation covered the principles and guidelines to accurately code under ICD-9, introduced the concepts of ICD-10, and presented how the thousands of diagnostic codes are distilled into the fewer than 100 HCCs to produce the HCC score for a patient.

HCC is a critical component of payment formulas in government and private health plans as it is used to express the expected cost of health care for an individual. Thus, the more accurate the diagnostic coding, the more accurately the HCC will project the expected cost. This is important as an increased proportion of practice payment will come from more government and private payment programs based on HCC (as compared to volume based CPT fee for service payment).

CMS Official Sean Cavanaugh Gives Closing Keynote

The Annual Meeting closed on a high note as Sean Cavanaugh, Deputy Administrator and Director, CMS provided the closing keynote address. Mr. Cavanaugh spoke of the preliminary success of the Accountable Care Act (ACA) in addressing quality and cost. The success is reflected in data such as the slowing rate of per capita increase in Medicare spending, reduced re-admission rates, and reduced rates of hospital acquired conditions.

Mr. Cavanaugh spoke of Secretary of the Department of Health and Human Service Burwell's emphasis in health care delivery that leads to better, smarter, and healthier

Membership, Programs & Services

1. Membership Diversification: The AAHCM continues to be delighted with the growth in diversity of our membership, with a current total membership around 1,300. Nurse Practitioners and Physician Assistants make up nearly 17% of our membership. About 64% of our membership is made up of physicians, of which 5% are Medical Directors, Remaining members include employees of home health agencies, administrators, residents and provider groups.

2. Public Policy: 2014 was the second year of the 3-year Independence at Home Demonstration, a decade-long effort of the Academy. The AAHCM also provided comments on numerous regulations including reform of the Medicare physician payment formula, meaningful use measures, audit and billing issues, and worked on new codes for transitional care, chronic care coordination and other matters.

3. Annual Scientific Meeting and Member Recognition:

The 2014 program "If Value is the Question, Home Care Medicine is the Answer" featured presentations on home care medicine for special populations, creative approaches to complex patients, measuring success in home care medicine, expert discussion seminars, and excellent networking opportunities. Winner of the Eric Baron House Call Doctor of the Year award was Dr. Thomas Lally. Winner of the Clinician of the Year award was Jeffrey Hulley, PA. Winner of the first House Call Educator of the Year award was Dr. Namirah Jamshed. Poster of the Year Award winners were Dr. Bruce Kinosian(Professional), Winnie Sun, BscN (Student), and Dr. Jennifer Voorhees (Trainee).

4. Newsletter: This year's bi-monthly editions of *Frontiers* have covered abstracts of the home care medicine literature and a variety of public policy, clinical and practice management topics, including a VA Perspectives column and strategic thinking columns. A weekly e-Newsletter continues to communicate the most up-to-date regulatory and practice management information to members. Back issues of *Frontiers* and the e-Newsletter are available in the member's only section of the website.

5. Medical Director Training: Through a grant, the Academy co-developed and hosted a web-based training program for Medical Directors of Home Health Agencies, which has remained active all year.

6. Medical Malpractice Insurance: Our agreement with Lockton Affinity continues, allowing medical malpractice insurance to be offered to our members.

Update of the Home Care Literature: *May - June 2015*

The goal of this column is to briefly review interesting articles appearing in the recent home care literature with a focus on articles relevant to physicians. The reviews are not meant to be comprehensive or stand alone but are intended to give readers enough information to decide if they want to read the original article. Because of the decentralization of the home care literature, there are likely to be significant articles that are overlooked and these categories are by no means set in stone. Readers are encouraged to submit articles or topics that may have been missed.

Assessment

Hartog LC, Cizmar-Sweelssen M, Knipscheer A, Groenier KH, Kleefstra N, Bilo HJ, van Hateren KJ. The association between orthostatic hypotension, falling and successful rehabilitation in a nursing home population. Arch Gerontol Geriatr. 2015 May 18. doi: 10.1016/j. archger.2015.05.005. The objectives of this study were to identify the prevalence of orthostatic hypotension (OH) in frail, elderly nursing home residents, and assess its possible association with falling and chances of successful rehabilitation. This was a prospective observational cohort study. A total of 290 patients participated in this study, of which 128 were admitted to the rehabilitation department. The conclusion of this study was that OH is highly prevalent in nursing home residents. Surprisingly, patients with OH were found to have a higher chance of successful rehabilitation compared to patients without OH. If confirmed in other studies, these results may change our view of the implications of OH.

Home Care Research

Ornstein KA, Leff B, Covinsky KE, Ritchie CS, Federman AD, Roberts L, Kelley AS, Siu AL, Szanton SL. Epidemiology of the Homebound Population in the United States. JAMA Intern Med. 2015 May 26. doi: 10.1001/jamainternmed.2015.1849.

The main objectives of this study were to develop measures of the frequency of leaving and ability to leave the home and to use these measures to estimate the size of the homebound population in the US population. It was cross-sectional data from the National Health and Aging Trends Study collected in 2011 in the contiguous United States. Participants were a nationally representative sample of 7603 noninstitutionalized Medicare beneficiaries 65 years and older. The authors concluded that in total, 5.6% of the elderly, community-dwelling Medicare population (approximately 2 million people) were completely or mostly homebound in 2011. Those findings can inform improvements in clinical and social services for these individuals.

Article of the Month

Quality of Care

Xin H, Kilgore ML, Sen BP. Is Access to and Use of Primary Care Practices that Patients Perceive as Having Essential Qualities of a Patient-Centered Medical Home Associated With Positive Patient Experience? Empirical Evidence From a U.S. Nationally Representative Sample. J Healthc Qual. 2015 Apr 4.

The patient-centered medical home (PCMH) has emerged as an innovative healthcare delivery model that holds the conceptual promise to improve healthcare quality and patient experience. This study examined how patient perceived PCMH is related to patient satisfaction and experience nationwide. This retrospective cohort study used data from the 2010 to 2011 Medical Expenditure Panel Survey. This study focused on insured individuals aged 18 and older. The authors concluded that overall, the PCMH model was associated with improved patient satisfaction nationwide. Findings from this study have shed light on strategies of innovative healthcare delivery models in improving patient experience, which in turn, may translate to patients' compliance to treatment regimen and improved health outcomes.

community results. This will be achieved through a focus on incentives, care delivery, and information. It will support the Secretary's goals of linking 90% of fee-for-service payments to quality and value by 2018 and by linking 50% of Alternative Payment Model payments to quality and value by 2018. An example of this transition is that more than 405 ACOs are participating in the Medicare Shared Savings Program with 7.3 million assigned beneficiaries

in 49 states, plus DC and PR. A program concern Mr. Cavanaugh identified is that the program will grow in enrollment by 30 million beneficiaries between now and 10 years from now. This is the same amount of growth the program experienced in 50 years. This will produce increasing cost pressures and why the work of Academy members is so important.

Mr. Cavanaugh's participation is the

first time in history that the senior Medicare official had agreed to speak at a meeting of the AGS or the Academy. Academy members and Board can be proud that the field has reached a place in health care delivery and policy to be recognized by the participation of Mr. Cavanaugh.
